### **INSIDE INFORMATION ANNOUNCEMENT AND RESUMPTION OF TRADING**

This announcement is made by Goldway Education Group Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Director(s)**”) (the “**Board**”) of the Company confirms that the Hong Kong Police Force and the Securities and Futures Commission (collectively the “**Law Enforcers**”) jointly executed a search warrant and entered into the Company’s principal place of business in Hong Kong on 15 December 2021 for the purpose of an investigation relating to an alleged offence of money laundering and/or offences suspected to have been committed under the Securities and Futures Ordinance (the “**Investigation**”). Certain documents were seized by the Law Enforcers during the Investigation and Mr. Cheung Lick Keung (“**Mr. Cheung**”), the chairman and the executive director of the Company, and another staff of the Group were arrested by the Law Enforcers.

The Board would like to clarify that as at the date of this announcement, Mr. Cheung has been released on bail and no written confirmation has been received by Mr. Cheung from the Law Enforcers that the Investigation on Mr. Cheung has been completed. As at the date of this announcement some bank accounts of the subsidiaries of the Company were frozen by the Hong Kong Police Force. Mr. Cheung has confirmed that as at the date of this announcement, he has not been charged by the Law Enforcer for any offences.

As at the date of this announcement, save as disclosed above, no other Director and/or employee of the Company has been arrested and no prosecution has been laid against any member of the Board and/or senior management of the Company. As such, the Board considers that there has been no significant impact on the Company in view of the Investigation both financially and operationally.

Further announcements will be made in due course, as appropriate.

## **RESUMPTION OF TRADING**

At the request of the Company, trading in the shares of the Company on the Stock Exchange was suspended with effect from 9:00 a.m. on 17 December 2021 pending the publication of this announcement. Application has been made to the Stock Exchange for the resumption of trading in the shares of the Company from 9:00 a.m. on 22 December 2021.
