## SUMMARY

- The Offer Price has been determined at HK\$0.205 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- The Offer Size Adjustment Option has been fully exercised by the Joint Lead Managers to require the Company to issue and allot additional 22,500,000 Placing Shares, representing 15% of the number of the Offer Shares initially offered under the Share Offer, at the Offer Price of HK\$0.205 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%), and such Shares have been fully subscribed.
- Based on the Offer Price of HK\$0.205 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after (i) deducting the underwriting commissions and estimated expenses payable by the Company in relation to the Share Offer; and (ii) the exercise of the Offer Size Adjustment Option, is estimated to be approximately HK\$16.4 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” of the Prospectus.
- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 8,684 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 10,565,064,000 Public Offer Shares, representing approximately 704.3 times of the total number of 15,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer — Re-allocation of the Offer Shares between Placing and Public Offer” of the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 100 times of the number of Offer Shares initially available under the Public Offer, 60,000,000 Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 75,000,000 Offer Shares, representing approximately 43.5% of the total number of Offer Shares available under the Share Offer (after the exercise of the Offer Size Adjustment Option).

Based on the Offer Price of HK\$0.205 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after (i) deducting the underwriting commissions and estimated expenses payable by the Company in relation to the Share Offer; and (ii) the exercise of the Offer Size Adjustment Option, are estimated to be approximately HK\$16.4 million. - (a) as to approximately 77.4%, or HK\$12.7 million, for expansion of network by opening and/or acquiring seven tutorial centres in Hong Kong;

- (b) as to approximately 11.6%, or HK\$1.9 million, for enhancement of our existing centres, facilities and equipment and IT systems;
- (c) as to approximately 2.4%, or HK\$0.4 million, for staff training; and
- (d) as to approximately 8.6%, or HK\$1.4 million, for marketing and promotion and other brand building activities.

The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. At the close of the application lists at 12:00 noon on Tuesday, 22 November 2016, a total of 8,684 valid applications pursuant to the Public Offer on **WHITE and YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total 10,565,064,000 Public Offer Shares, representing approximately 704.3 times of the total number of 15,000,000 Public Offer Shares initially available under the Public Offer, were received.

Eight multiple applications or suspected multiple applications have been identified and rejected. No application has been rejected due to invalid application which is not completed in accordance with instructions on the relevant Application Form. One application has been rejected due to bounced cheque. No application for more than 100% of the Public Offer Shares initially available under the Public Offer, i.e. more than 15,000,000 Public Offer Shares (representing 10% of the total number of the Offer Shares available under the Share Offer), has been identified.

Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer — Re-allocation of the Offer Shares between Placing and Public Offer” of the Prospectus have been applied.
